## 2021 Electric Rebates

**Requirements applicable to all rebates listed in this document:** Funds begin Jan. 1, 2021 and are budgeted through December 31, 2021. Must be new equipment installed at a Red River Valley Co-op Power service. Red River Valley Co-op Power reserves the right to inspect all installations prior to a rebate being given. **Red River Valley Co-op Power reserves the right to end the program at any time once \$52,000 in total rebates has been given out.** Total maximum rebates for a residential account is \$3,000 and the maximum for a business account is \$5,000; more rebates for a project will be considered on a case-by-case basis. All rebates are given for new electric equipment only that uses electricity as its source of power. Copy of invoice or receipt is necessary for approval unless it is new home construction where site verification is more appropriate. **Electric heat rebates, except for heat pumps, must be on an approved off-peak program.**
